**CERTIFICATE OF SATISFACTION**

1. Complainant is Talitha Bradley.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. (a) Complainant, Talitha Bradley, and Respondent, PPL Electric agree that Complainant has alleged that she has never resided at 421 McClay Street, Harrisburg, PA 17110. However, this account was placed in Complainant's name as of December 10, 2011 through May 16, 2012. Respondent, PPL Electric agrees that it will remove all charges related to electric service provided at McClay Street upon Complainant providing Respondent with the following documents:
  - (b) Three forms of proof that Complainant was residing at a residence other than McClay Street during the time December 10, 2011 through May 16, 2012, which may include: copies of utility bills in Complainant's name showing an address different than McClay

Street; copy of Complainant's drivers' license showing an address different than McClay Street; copy of a rental or lease agreement in in Complainant's name showing an address different than McClay Street; or proof of rental payments, a notarized statement from the Township or Courthouse stating Complainant's residency at a difference address during the billing period, a notarized statement from an employer stating the time of employment, and Complainant's home address during the period of time, an official document from the Complainant's Postmaster stating a different address during the relevant time, or a W-2 form indicating a different mailing address during the relevant time. In addition, if the police are willing to accept a police report, Complainant must file a valid police incident report stating that she did not request service in her name at McClay Street, did not authorize another individual to place the account for McClay Street in her name, and believes her identity was stolen. To the extent Complainant makes any payments or receives any customer assistance from LIHEAP, On-Track or another source, such payments will not be applied to bills which were accumulated at McClay Street.

(c) Complainant agrees to withdraw her Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.
