On behalf of PSEG Energy Resources & Trade LLC, I am writing to confirm the following statements made by PSEG Energy Solutions LLC in the above-referenced application.

PSEG Energy Solutions is within the corporate structure of Public Service Enterprise Group Incorporated ("Enterprise"). Enterprise's major operating companies are Public Service Electric and Gas Company, a New Jersey public utility subject to the jurisdiction of the New Jersey Board of Public Utilities; and PSEG Power LLC ("Power"), a power producer in the U.S. with four main subsidiaries:

- PSEG Fossil LLC;
- PSEG Nuclear LLC;
- PSEG Energy Resources & Trade LLC; and
- PSEG Power Ventures.

PSEG Energy Solutions is a wholly owned subsidiary of PSEG Energy Resources & Trade LLC ("ER&T"). ER&T is a wholly owned subsidiary of PSEG Power LLC ("Power"). Initially, PSEG Energy Solutions will be capitalized with an equity infusion from PSEG ER&T, a wholly owned subsidiary of Power. In addition, PSEG Energy Solutions will have an intercompany loan from PSEG Power or one of its subsidiaries. Indirectly, PSEG Energy Solutions will also participate in a corporate money pool, which is an aggregation of daily cash balances designed to efficiently manage PSEG's short-term liquidity needs.

I, Carl J. Fricker, hereby state that the facts above set forth are true and correct to the best of my knowledge, information and belief, and that I expect to be able to prove the same at a hearing
