



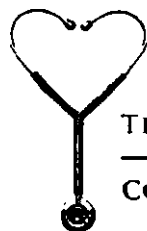
Attention PGW:
