Brent R. Brown (Respondent) has paid the civil penalty sought by the Bureau of Investigation and Enforcement (I&E) of the Pennsylvania Public Utility Commission (Commission) in order to resolve the above-docketed complaint without litigation.

On October 14, 2016, Respondent's insurer filed evidence of liability and cargo insurance with the Commission. On November 23, 2016, the Commission received a certified check in the amount of \$250, which constitutes payment of the reduced civil penalty sought by I&E for Respondent's failure to timely file evidence of liability and cargo insurance with the Commission.


