In accordance with 52 Pa. Code § 54.34, Town Square Energy East, LLC ("TSEE"), a licensed Electric Generation Supplier (EGS) hereby notifies the Pennsylvania Public Utility Commission ("Commission") of a change in its organizational structure.

Background

On August 26, 2010, Discount Energy Group, LLC ("Company" or "DEG") filed an application seeking to become a licensed EGS in all of the Electric Distribution Company service territories throughout the Commonwealth of Pennsylvania. On March 17, 2011, the Commission issued the license for the Company to supply electricity throughout the Commonwealth under Docket No. A-2010-2199551. On January 15, 2014, DEG submitted a notice to inform the Commission that it had been acquired by Retail Energy Holdings, LLC ("REH"), a wholly owned subsidiary of Twin Cities Power Holdings, LLC. On April 27, 2015, the Company filed a request that the Commission change the name on its EGS license to Town Square Energy East, LLC ("TSEE"). On July 21, 2015 the Commission approved the name change.

Change in Organizational Structure

TSEE hereby notifies the Commission that on November 2, 2016, an equity purchase agreement between REH and Genie Retail Energy, Inc. ("Genie Retail"), a subsidiary of publicly-traded Genie Energy Ltd., was consummated. A seamless change in control has been effected and Genie Retail is now the owner of 100% of REH. TSEE has thus become a second-tier subsidiary of Genie Energy Ltd.

A graphical depiction of the Company's new corporate organizational structure is attached as *Exhibit A*.

As a wholly-owned second-tier subsidiary of Genie Energy Ltd., TSEE's financial profile has been strengthened significantly, as demonstrated by the most recent public filings of Genie Energy Ltd. (NYSE:GNE), which are available on the Securities and Exchange Commission's EDGAR website: <u>https://www.sec.gov/edgar/searchedgar/companysearch.html</u>.

Genie Retail has several other subsidiaries that are licensed by the Commission as electricity and natural gas suppliers.


