MOTION TO WITHDRAW APPLICATION OF DANACH LLC
FOR LIMOUSINE AUTHORITY WITHOUT PREJUDICE

Danach LLC by its undersigned counsel and pursuant to 52 Pa. Code §5.94 hereby submits a petition for leave to withdraw its Application for Limousine Authority filed on November 8, 2013 without prejudice and in support avers as follows:

1. On or about November 8, 2013 Petitioner filed an Application for Limousine Service in the Counties of Montgomery, Bucks, Delaware and Chester.
2. The Application was published in the Pennsylvania Bulletin on December 7, 2013
3. Protests were filed by Germantown Cab Company, Five Star Limousine, Black Tie Limousine and Luxury Sedan Services
4. All of the protestants are represented by Michael S. Henry, Esquire
4. Applicant is an entity affiliated with Uber Technologies Inc which was working on establishing Legislation for Transportation Network Companies (TNC)
5. During the pendency of this Legislation this matter has been stayed and the Petitioner filed status reports with the court updating them on the prospect of further litigating the Application.

6. On November 4, 2016 Governor Wolf signed Act 164 of 2016 into Legislation authorizing TNC service throughout the Commonwealth of Pennsylvania.

7. Applicant has decided at this point there is no need to pursue a further application with the Commission and that it would be a waste of the parties time and Commission resources.

8. Applicant had discussed this matter with counsel for the Protestants and they have no objection to the withdraw of the present Application


9.. The Petitioner seeks to now withdraw the present Application pending before Judge Christopher Pell.

8. The withdraw of the Application is in the public interest as the withdraw is agreed to among the parties and litigation would merely be a waste of Commission resources.
