Please accept this notification of Joint Complainants of compliance with paragraph 38 of the Joint Petition for Approval of Settlement, page 38 of the Initial Decision dated June 8, 2015, and page 19 of the Commission's Tentative Form Opinion and Order dated March 9, 2016 and deemed final as of March 16, 2016 in the above-captioned proceeding. On December 13, 2016, the Commonwealth of Pennsylvania, Office of Attorney General, through the Bureau of Consumer Protection and the Acting Consumer Advocate, Tanya J. McCloskey provided the November Report of the Administrator of the Refund Pool to Energy Services Providers, Inc. d/b/a Pennsylvania Gas & Electric (PaG&E), the Pennsylvania Public Utility Commission's Bureau of Consumer Services, and Administrative Law Judges Elizabeth Barnes and Joel Cheskis in the format and medium requested by each.

Specifically, 51,845 checks were issued on August 12, 2016, representing checks to all eligible customers. Through November 30, 2016, of those checks issued, 39,636 refund checks

totaling \$1,860,105.03 were cashed and paid; 2,705 refund checks totaling \$124,815.40 were returned undeliverable; and 9,504 refund checks totaling \$340,079.35 were delivered and still uncashed.
