Your request for a name change is being returned as incomplete. Commission regulations at 52 Pa Code §3.381(a) (6) (i) (A) (II) - (V) require:

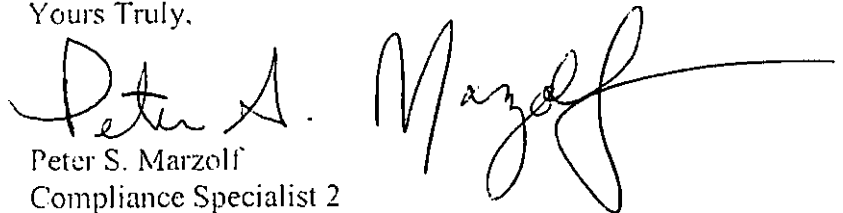
