**MOTION FOR CONTINUANCE OF HEARING**

Pursuant to 52 Pa. Code § 1.15(b), Philadelphia Gas Works, the Respondent (PGW) hereby requests a continuance of the hearing in this matter scheduled for Friday, January 6, 2016. In support of its motion, PGW states as follows:

1. The instant Complaint was filed by the Complainant on September 2, 2016.
2. On October 12, 2016, PGW filed the Answer.
3. By Notice dated November 4, 2016, the Commission scheduled an In-Person Hearing in this matter for Friday, January 6, 2016 at 10:00 a.m., before Administrative Law Judge Cynthia W. Fordham.
4. PGW is in the process of attempting to investigate claims in the Complaint by scheduling a visit to the Service Address.
5. PGW contacted Mr. Kuebler, the Complainant, by telephone to discuss a continuance and schedule a visit to the Service Address. Not only did Complaint refuse to schedule a time for PGW to come out and investigate, but also, when asked about whether he agreed to the continuance, the Complainant indicated that he did not agree; when asked if he objected to the continuance, he stated that he "did not say that either."
6. Complainant refused to agree or object to PGW's request despite being informed that PGW could not adequately address the claims made in the Complaint without an opportunity to investigate said claims, which would require a further investigation of the Service Address.

**WHEREFORE**, Complainant requests that the hearing scheduled for Friday, January 6, 2016, in the above captioned matter be continued and rescheduled so that PGW may make a further attempt to speak with the Complainant and schedule an on-site investigation of the Service Address.
