12/28/06 Delauter's A-1 Services, Inc., filed an amended application per ALJ Salapa's order. The applicant was required to re-file as John C. Delauter, t/a Delauter's A-1 Services because the corporation had been dissolved.

4/12/07 ALJ Salapa's initial decision is served to the parties. Judge Salapa granted household goods in use authority to John C. Delauter, t/a Delauter's A-1 Services at A-00122443. Exceptions to be filed by 5/2/07 – reply exceptions by 5/14/07.
