BRIEFING ORDER

I conducted the initial hearing in this matter on November 16, 2006. During the hearing, the testimony of the witnesses and a review of the application revealed two mistakes in the notice published in the Pennsylvania Bulletin.

In order to correct these errors, I issued an order dated November 17, 2006, directing the Commission's Bureau of Transportation and Safety to republish the application in the Pennsylvania Bulletin with the applicant's correct name and the portion of the application requesting authority to transport household goods between points in York County. I held the record open in this proceeding until notice of the application was republished in the Pennsylvania Bulletin.

Subsequently, I issued an order date November 30, 2006 directing the applicant to file an amended application setting forth its change in status from a corporation to a sole proprietorship and the name under which it proposes to operate. In response, the applicant filed an amended application with the Commission on December 12, 2006.

Upon the applicant filing the amended application, the Commission's Bureau of Transportation and Safety caused notice of the amended application, including the portion of the original application requesting authority to transport household goods between points in York County, to be republished in the Pennsylvania Bulletin dated January 20, 2007 at 37 Pa.B. 381. The

notice stated that the deadline for filing protests was February 12, 2007. No protests were filed to the amended application. The parties subsequently agreed to a briefing schedule.

THEREFORE,

IT IS ORDERED:

1. That the parties shall file and serve main briefs on or before March 16, 2007 and will file and serve reply briefs on or before March 30, 2007.

2. That the briefs must contain the following as set forth at 52 Pa. Code §5.501:

(A) A statement of the questions involved.

(B) A concise statement or counter-statement of the case.

(C) Where evidence is relied upon by the party filing the brief, the party shall make reference to the pages of the record or exhibits where the evidence appears.

(D) An argument preceded by a summary.

(E) Proposed findings of fact with references to transcript pages or exhibits where evidence appears.

(F) Proposed conclusions of law.

(G) Proposed ordering paragraphs specifically identifying the relief sought.

(H) A conclusion with requested relief.

3. That, consistent with 52 Pa. Code §5.502, the parties shall file an original and nine copies of the briefs with the Commission pursuant to 52 Pa. Code §1.4 no later than 4:30 p.m. on the dates listed, addressed as follows:


