PROCEDURAL SCHEDULE

An Initial Hearing convened on Thursday, June 29, 2006, at 10:00 a.m. During the course of the hearing it was recognized that several matters needed to be presented as written argument for decision. The parties attempted to reach a mutually agreeable schedule to present their positions by written argument. This Order is a result of the agreed to schedule.

Mr. Melvin Sharpe, Jr., Esquire appeared representing the Complainant, Mr. Haneef Hasan aka Robert Moore. Mr. Laureto Farinas, Esquire appeared representing Philadelphia Gas Works ("PGW" or "Company" or "Respondent). The issue of authority of the Pennsylvania Public Utility Commission ("Commission") to act in this matter was raised relating to whether the statute of limitations has run and whether the action of PGW under a Municipal Lien Act prohibits the Commission. The parties agreed to present substantive arguments on these matters as well as the merits of the dispute through briefs. The following represents the agreed upon procedural schedule:

2. In addition to complying with 52 Pa. Code §§ 5.501 et seq., the parties shall serve one copy of the briefs on me when filed.


3. If the filing of exceptions and reply exceptions becomes necessary, the parties shall serve a copy on the Commission's Office of Special Assistants.


