INTERIM ORDER¹

Before

On March 19, 2004, Ms. Sandra Cupeles ("Complainant") filed a formal Complaint against PPL Electric Utilities Corporation ("PPL" or "Respondent" or "Company") alleging a high bill for her electric utility service and requesting that her service be checked. On April 13, 2004, PPL filed an Answer denying that the Complainant was billed in excess of electricity consumed. PPL stated further that it tested the Complainant's meter which showed 99.5% accuracy and the Company's investigation revealed that the Complainant's actual usage was less than her potential usage.

This case was assigned to me pursuant to 52 Pa. Code § 56.174. A Corrected Initial Telephone Hearing Notice dated August 11, 2004, was sent to the parties stating a scheduled telephonic hearing for Monday, October 4, 2004 at 1:30 p.m.

A Prehearing Order was issued on September 15, 2004, advising the parties of the date and time of the scheduled hearing, and that the case could be dismissed if they failed to appear for the hearing and failed to obtain a continuance. The Prehearing Order also reminded

the parties of their responsibility to notify me of any change in the telephone number where they could be contacted for the hearing.

In accordance with the Prehearing Order, by cover letter dated September 29, 2004, PPL submitted three (3) copies of four (4) proposed exhibits for possible use at the Initial Telephonic Hearing.

On October 4, 2004, I attempted to convene the Initial Telephonic Hearing. Ms. Kimberly Spotts-Kimmel, Esquire appeared, via telephone, on behalf of PPL.² I attempted to contact Ms. Cupeles at (717) 291-0201, the home phone number listed on the Complaint. The phone was answered by a gentleman stating he didn't speak English but asked if I was PPL. The attempted exchange revealed that the gentleman's name was Angel Cupeles, the husband of the Complainant. The Company stated that they were not aware of Mr. Cupeles and that he was not the Complainant of record. Mr. Cupeles did not remain on the telephone during the exchange that occurred on the record and the Company moved to dismiss the proceeding for lack of prosecution. I represented that the Motion was granted.

I have reconsidered the basis for the Motion to Dismiss and will hold it in abeyance to be considered at the further hearing to be scheduled. Mr. Cupeles represented that he was the husband of Ms. Cupeles, that he paid the PPL light bill and that he did not speak English. He may have hung up on the telephonic hearing because he did not comprehend what was taking place. The Commission will schedule a further hearing where the Commission will have a translator available who can comprehend both Spanish and English to assist in a hearing on this matter. I request that the rescheduling of this matter be expedited so that the dispute may be concluded promptly. I also suggest to PPL that they consider Mr. Cupeles' language impediment with exhibits, documents and letters.

The Complainant is reminded of her obligation to make regular monthly payments towards her electric bill while awaiting a hearing on her complaint, consistent with the

Commission's Order in Charles Stammel v. PG Energy Co., A Division of Southern Union Company, Opinion and Order entered May 21, 2003 at Docket No. C-20027994.

The Complainant, Sandra Cupeles, and any other individuals seeking this Complaint on her behalf are hereby directed to pay the PPL Electric Utilities Corporation bills for the residence at 2864 Dell Lane, Lancaster, Pennsylvania, 17603 on or before the billing due date, unless otherwise directed by the undersigned presiding officer, until a final Commission Order is issued or until this proceeding is otherwise resolved.

FAILURE TO COMPLY WITH THIS ORDER MAY RESULT IN THE TERMINATION OF YOUR SERVICE. THE UTILITY MUST GIVE YOU TERMINATION NOTICES AS REQUIRED BY 52 PA CODE CHAPTER 56.


ORDER

En Marzo La 19 De 2004, Ms. Sandra Cupeles ("Complainant") archivó una demanda oficial contra PPL de la compañía de electricidad ("PPL" o "respondedor" o "compañía") alegando un los billes de electricidad eran muy altos. De abril el 13 de 2004, PPL archivó una respuesta que negaba a eso el Complainant fue mandado la cuenta en el exceso de la electricidad consumido. PPL indicó más lejos que él probó el metro del Complainant que demostró 99. exactitud del 5% y la compañía la investigación reveló que el uso real del Complainant eramenos que ella uso potencial.

Este caso era asignado a mí conforme a PA 52. Cifre el § 56.174. Una Inicial Corregida Llame por teléfono el aviso de la audiencia anticuado de agosto el 11 de 2004, fue enviado a la indicación de los partidos una audiencia telefónica programar para lunes, de octubre el 4 de 2004 en 1:30 p.m.

Un la orden fue publicada en septiembre el 15 de 2004, aconsejandolos partidos de la fecha y época de vista, y ésa el caso se podía despedir si ellos no pudo aparecer para la audiencia y no pudo obtener una continuación. El Prehearing La orden también recordó los partidos su responsabilidad de notificarme de cualesquiera cambio en el número de teléfono donde podrían ser entrados en contacto con para la audiencia.

De acuerdo con la orden de Prehearing, por la letra de cubierta anticuada de septiembre el 29 de 2004, PPL sometió tres (3) copias de cuatro(4) objetos expuestos propuestos para el uso posible en Audiencia Telefónica Inicial.

En octubre el 4 de 2004, procuré convocar la audiencia telefónica inicial. Ms. Kimberly Spotts-Kimmel, Esquire apareció, via el teléfono, a nombre de PPL.^[2] Procuré entrar en contacto con a Sra. Cupeles en (717) 291-0201, el número de teléfono casero enumeró en la queja. El teléfono fue contestado por un caballero indicando que él no lo hizo hablar en inglés pero preguntó si era PPL. Procurado intercambiado revelado eso el nombre del caballero era Ángel Cupeles, el marido del Complainant. La compañía indicó que no estaban enterados de Sr. Cupeles y ese él no era Complainant del expediente. Sr. Cupeles no permanecía en el teléfono durante intercambio eso ocurrió en el expediente y la compañía se movió para despedir el proceder para la carencia del procesamiento. Representé que el movimiento fue concedido.

Tengo reconsideró la base para que el movimiento desista y llevará a cabo en la suspensión ser considerado en la audiencia posterior para programar. Sr. Cupeles representado que era el marido del Sra. Cupeles, de que él paga la luz a PPL cuenta y esa él no habló inglés. Él pudo haber colgado para arriba en el telefónico el oír porque él no comprendió qué ocurría. La Comisión programar otra audiencia donde la Comisión tendrá un traductor disponible quién puede comprender español y el inglés asistir a una audiencia encendido esta materia. Solicito que el cambio de hora de esta materia esté apresurado tan que el conflicto se puede concluir puntualmente. También sugiero a PPL que ellos considere a impedimento de la lengua de Sr. Cupeles con los objetos expuestos, los documentos y las letras.

Complainant se recuerda su obligación de hacer cuotas regulares hacia su cuenta eléctrica mientras que aguarda una audiencia en su queja, constante con la petición de la Comisión dentro Charles Stammel v. Energía Co de la PÁGINA., Una División de Southern Union Company. la opinión y la orden incorporaron de mayo el 21 de 2003 en el No. del docket. C-20027994.
