REVISED ORDER CONCERNING
APPLICATION FOR SUBPOENA

On August 15, 2006, I received an e-mail from counsel for the Respondent, indicating that Carl Weyandt had retired from the City of Altoona, effective August 11, 2006. The subpoena that was issued yesterday, August 14, 2006, states that Mr. Weyandt's address is 1301 12th Street, Suite 300, Altoona, PA, which was his prior work address. His address is now 2817 Walnut Street, Altoona, PA, 16601; the home address. There is insufficient time to issue and serve another original signed subpoena with the home address, as the hearing is scheduled for August 30, 2006. Also, Pennsylvania Public Utility Commission regulations provide for service of subpoenas by mail. 
