ORDER GRANTING
MOTION FOR CONTINUANCE

A Hearing Notice dated June 14, 2006, indicated that an Initial Hearing was scheduled for this proceeding on Tuesday, August 15, 2006, at 10:00 a.m. By correspondence dated July 25, 2006, a request was made to reschedule the hearing because Elisabeth Colbath-Czech, Complainant, as well as her counsel, Mr. Paul Czech, Esquire, were scheduled to be out-of-town on a pre-paid vacation on August 15, 2006. The correspondence did not represent whether Verizon Pennsylvania Inc. ("VZPA" or "Respondent") was consulted regarding the request.

On August 7, 2006, I placed a telephone call to counsel for the Complainant and left a message stating that the request was deficient because it did not provide Respondent's status regarding the request. By electronic mail on August 8, 2006, Ms. Janet Miller, Esquire, stated that VZPA does not object to the continuance request.

The Prehearing Order dated June 20, 2006, at ¶ 2 states, "A request for a change of the scheduled hearing date must state the agreement or opposition of other parties, and must be submitted in writing no later than five business days prior to the hearing." This procedure is in accordance with Commission regulation at 52 Pa. Code § 1.15(b). This matter is ripe for review.


