ORDER GRANTING REQUEST

By Hearing Notice dated March 30, 2006, a hearing was scheduled in this matter for May 1, 2006. By letter received by me on April 25, 2006, respondent PPL Gas Utilities Corporation (PPL) requested that the hearing be continued and rescheduled due to the unavailability of a witness who will be on vacation.

I am reluctant to grant this request. If Mr. Kinter's vacation was scheduled prior to receipt of the Hearing Notice, then there is no excuse for this lateness. If his vacation was scheduled so as to prevent the timely filing of this request, then the request is unreasonable on its face. In addition, there is no indication that the proposed witness is the only PPL employee in a position to testify.

As complainant indicated that it did not oppose this request, however, it will be granted. PPL is cautioned that no further continuances will be granted, except for extremely good cause.

I urge the parties to use this opportunity to discuss the matter directly with each other so that a hearing may not be necessary.
