

The Respondent in this case has requested the Commission to issue an interim payment order directing the Complainant to comply with the Commission's Bureau of Consumer Services decision of April 22, 2004.

Based on a review of the pleadings, and having in mind the Commission's decision in Charles Stammel v. PG Energy, A Division of Southern Union Co., Docket No. C-20027994 (entered May 21, 2003), IT IS HEREBY ORDERED THAT Robin Brooks shall pay to PECO Energy Company for all utility services provided to Robin Brooks during the pendency of this matter.

Failure to comply with the payment terms of this order may result in the termination of utility service to Robin Brooks even prior to any hearing scheduled to be held. Failure to comply may also result in the issuance of an order for Robin Brooks to make a lump sum payment equal to all missed payments.
