And Now comes Respondent, UGI Penn Natural Gas, Inc. (PNG), pursuant to 52 *Pa. Code*, Section 5.103 (a) and (b) and files the following Motion for Consolidation:

1. On or about November 3, 2016 Complainant filed the above-captioned Formal Complaint with the Commission.
2. The Complaint was served on PNG by Secretarial Letter dated November 4, 2016.
3. On or about November 10, 2016, PNG filed an Answer to the Complaint with the Secretary of the Commission.
4. A telephonic hearing is currently scheduled for February 23, 2017.
5. On or about November 28, 2016, Complainant filed a second Formal Complaint with the Commission that was docketed at C-2016-2578856.
6. On May 25, 2016, PNG filed an Answer to the second Complaint with the Secretary of the Commission.
7. Both Complaints involve a request for a payment agreement and contain similar averments of fact that may or may not be relevant or material.

Wherefore, PNG moves that the two Complaints be consolidated for the purpose of a telephonic hearing before the Commission.
