**INTERIM ORDER**  
**SETTING CONFERENCE BETWEEN PARTIES**

On or about December 17, 2004, Charles J Eder Jr ("Complainant") filed a complaint against Aqua Pennsylvania Inc ("Respondent"), at the above-captioned docket number. On or about February 11, 2005, Respondent filed an Answer to the complaint.

Based upon a review of the pleadings, the parties are hereby directed to discuss this matter to determine whether such discussion can result in a resolution of the complaint and, if so, whether Complainant wants to withdraw the complaint. Respondent shall contact Complainant, on or before March 2, 2005, concerning a mutually convenient time, date and place for Respondent and Complainant to hold a conference. The conference shall take place on or before March 16, 2005, unless this is not possible.

Within ten (10) days following the conference, Respondent shall file a short report with Bruce Bigelow, Mediator ("Mediator"), setting forth:

- (a) The time, date and place of the conference;
- (b) Who participated for each party; and
- (c) A statement on the results of the conference.


