



Dear Secretary McNulty:

By Final Order entered February 23, 2003, the Pennsylvania Public Utility Commission ("Commission") approved without modification a decision by Administrative Law Judge Michael A. Nemec approving a Joint Petition for Full Settlement filed by and on behalf of James L. Ferguson, the Office of Consumer Advocate, CEI Networks, Inc., The United Telephone Company of Pennsylvania d/b/a Sprint and Verizon Pennsylvania Inc., docketed at C-20027384. Pursuant to paragraph 14(c)¹ and paragraph 16(c)² of the approved settlement, the settlement arrangement is no longer required given that Sprint now completes the calls in the above-referenced matter on its own network.

Specifically, in 2003, Sprint began converting its local circuit switched network to a packet switched network. Sprint's Mill Hall host office has been converted to the new packet

¹ Paragraph 14(c) in relevant part provides as follows:

The continuation of the arrangement is subject to technical feasibility, cost effectiveness, and network modifications (i e., number porting, packet switch upgrades) of carrier Parties, Sprint and CEI.

² Paragraph 16 in relevant part provides as follows:

The terms and conditions of this Agreement shall continue unless the terms and conditions are:


- (c) Terminated or modified by either Sprint or CEI, upon written notification to the Commission and all Parties on basis of the limitations set forth in paragraph 14, above;

switched network. One of the benefits of the new network is that Sprint is now able to complete interLATA local calls originated by its customers in the Howard and Zion exchanges to CEI customers in the State College and Bellefonte exchanges on its own network. Sprint customers in the Howard and Zion exchanges calling CEI customers in State College or Bellefonte will continue to do so, toll-free, by dialing seven-digits. The change in Sprint's routing of the call will be "transparent" to the customer. Accordingly, Sprint is terminating the arrangement underlying the Settlement.


