Please accept this notification of Joint Complainants of compliance with paragraph 39(d) of the Joint Petition for Approval of Settlement, pages 36-37 of the Initial Decision dated November 19, 2015, and page 15 of the Commission's Tentative Form Opinion and Order entered June 30, 2016 and deemed final as of July 8, 2016 in the above-captioned proceeding. On January 13, 2017, the Commonwealth of Pennsylvania, Office of Attorney General, through the Bureau of Consumer Protection and the Acting Consumer Advocate, Tanya J. McCloskey provided the December Report of the Administrator of the Refund Pool to IDT Energy, Inc., the Pennsylvania Public Utility Commission's Bureau of Consumer Services, and Administrative Law Judges Elizabeth Barnes and Joel Cheskis in the format and medium requested by each.

Specifically, 68,298 checks were issued on September 23, 2016, representing checks to all eligible customers. Of those checks issued, 45,416 totaling \$1,647,845.86 were cashed and paid; 7,154 totaling \$281,781.14 were returned undeliverable; and 15,728 totaling \$470,372.65 were delivered and still uncashed.
