2 ADMINISTRATIVE LAW JUDGE LARRY GESOFF: This is the
3 time and place set by the Pennsylvania Public Utility
4 Commission for an initial hearing by telephone in the
5 complaint of Rebecca Billingslee against The Peoples Natural
6 Gas Company doing business as Dominion Peoples at Docket No.
7 C-20065795.

8 I am Larry Gesoff, the administrative law judge
9 assigned to this proceeding. I note the appearance of
10 Rebecca Billingslee on behalf of herself and of Horace P.
11 Payne, Jr., on behalf of Dominion Peoples.

12 When I connected Ms. Billingslee to the call she asked
13 if she could just drop this matter. I take it that, Ms.
14 Billingslee, you wish to withdraw your complaint?

15 MS. BILLINGSLEE: Correct.

16 JUDGE GESOFF: Mr. Payne, I assume that's all right
17 with the company.

18 MR. PAYNE: Your Honor, no objection here.

19 JUDGE GESOFF: Okay. All right. Ms. Billingslee,
20 what will happen is you'll receive a one-sentence letter
21 from the Commission saying that the case is closed. You
22 figure it would take a week or two to do it, but it will
23 probably take a month or two.

24 MS. BILLINGSLEE: That's fine.

25 JUDGE GESOFF: So when you receive that letter you'll
