
INTERIM PAYMENT ORDER

On or about October 31, 2001, the Commission's Bureau of Consumer Services (BCS) directed Gayle Kyles to pay a regular monthly budget amount of \$53.00 plus \$15.00 per month toward the arrearage. Pursuant to Section 56.174(3) of the Commission's regulations (pertaining to stays and payment orders) Duquesne Light Company has requested the issuance of an interim payment order directing Gayle Kyles to make the payments directed by the BCS until the Commission's Order is entered in this case, or the case is otherwise resolved.

Based upon a review of the pleadings, Gayle Kyles shall pay the regular monthly budget amount, plus an additional \$15.00 per month toward the arrearage and shall continue to make these monthly payments until such time as a different payment arrangement may be established in this case.

FAILURE TO COMPLY WITH THIS ORDER MAY RESULT IN THE TERMINATION OF GAYLE KYLES' SERVICE. DUQUESNE LIGHT COMPANY MUST GIVE TERMINATION NOTICES AS REQUIRED BY 52 PA. CODE, CHAPTER 56.

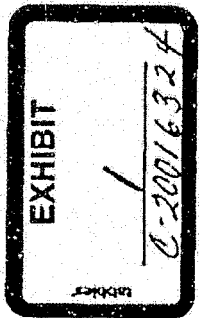
