ORDER GRANTING REQUEST
FOR CONTINUANCE

By letter dated January 27, 2005, complainant Woodard sent a letter to Lisa Lutz, Esq., counsel for respondent PECO, requesting that the hearing scheduled for February 15, 2005 be rescheduled because she and her husband have a paid, planned vacation for the period February 14-15, 2005. Ms. Lutz faxed the letter to me and informed Ms. Woodard that she needed to request the change from me. Ms. Lutz did not indicate if PECO opposed this request.

With some reluctance, I will grant the request since it is the first continuance requested by this party and therefore direct that the hearing scheduled for February 15, 2005 be continued and rescheduled. Ms. Woodard also in her letter included a series of dates on which she claimed she would not be available because of employment commitments, although she did not indicate the precise time of unavailability or if she would be available telephonically. She should be aware that it may not be possible to accommodate those other dates, as hearing dates are determined by my schedule. In any event, to accommodate her, I will direct that the hearing be rescheduled for a date after March 22, 2005.


I do urge the parties to use this opportunity to attempt to resolve the matter themselves, so that a hearing will not be necessary.

THEREFORE,

IT IS ORDERED:

1. That the request for continuance made by complainant Janine Woodard at Docket No. C-20044005 is granted; and
2. That the hearing scheduled for February 15, 2005 is continued and will be rescheduled to a date after March 22, 2005.




