INTERIM ORDER  
SETTING CONFERENCE BETWEEN PARTIES

On or about February 7, 2001, Mary & Salvatore Danese ("Complainant") filed a complaint against Philadelphia Gas Works ("Respondent"), at the above-captioned docket number. On or about March 8, 2001, Respondent filed an answer to the complaint.

Based upon a review of the pleadings, the parties are hereby directed to discuss this matter to determine whether such discussion can result in a resolution of the complaint and, if so, whether Complainant wants to withdraw the complaint. Respondent shall contact Complainant, on or before April 2, 2001, concerning a time, date and place for Respondent and Complainant to hold a conference. The conference shall take place on or before April 16, 2001, unless this is not possible.

Within ten (10) days following the conference, Respondent shall file a short report with Herbert R. Nurick, Mediation Coordinator ("Coordinator"), setting forth:

- (a) The time, date and place of the conference;
- (b) Who participated for each party; and
- (c) A statement on the results of the conference.

If it is not possible to have the conference by the date set for that purpose, Respondent shall file a report with the Coordinator, on or before ten (10) days following the conference due date, giving the reason(s) why the due date could not be met.

In either situation, a report must be filed with the Coordinator by the applicable due date set forth above.
