ORDER GRANTING
MOTION FOR CONTINUANCE

A Hearing Notice dated March 8, 2007, indicated that an Initial Hearing was rescheduled for this proceeding on Tuesday, April 3, 2007, at 10:00 a.m. On the morning of Monday, April 2, 2007, I received by telephone call followed by facsimile a request from Mr. Michael S. Swerling, counsel for PECO Energy Company ("Respondent" or "Company") to reschedule the hearing. The Respondent stated that he had taken ill. Mr. Swerling also indicated that he had spoken with Ms. Carol McGeoy and she agreed to continue the case. While speaking with Ms. McGeoy, Mr. Swerling stated that the Company would make efforts to better address the concerns complained of. The Company is hopeful the time provided through the continuance may work to settle this matter.

My Prehearing Order at ¶ 2 states, "A request for a change of the scheduled hearing date must state the agreement or opposition of other parties, and must be submitted in writing no later than five (5) business days prior to the hearing." This procedure is in accordance with Commission regulation at 52 Pa.Code § 1.15(b). This matter is ripe for ruling.

Mr. Swerling operated under extenuating circumstances and attempted to comply with the procedure in my Prehearing Order. Although he did not obtain provide communication of his intent to continue the proceeding in the requisite amount of days, falling ill cannot be scheduled. Appropriate measures were taken to obtain to comply with the spirit of the order and the Commission's regulation.






