17 Mr. Green's account for gas service which is the
18 subject of this discussion is \$1,272.84. PGW has given
19 Mr. Green a credit in the amount of \$322.84 leaving a
20 balance of \$950.00.

21 Mr. Green's new payment arrangement will be
22 \$89.00 per month and -- I'm sorry, the arrangement will
23 be for \$110.00 per month, that's \$90.00 for the present
24 and \$20.00 towards the arrears for a total of 48 months.

25 JUDGE NGUYEN: Thank you. Do you have any other

1 cases for this morning?

2 MR. FARINAS: No, Your Honor.

3 JUDGE NGUYEN How about for this afternoon?

4 MR. FARINAS: Yes, Your Honor, Ms. Hattie Howell.

5 JUDGE NGUYEN: Mr. Green, do you agree with this?

7 JUDGE NGUYEN: Okay. Thank you. See you this
8 afternoon.
