**INTERIM ORDER  
SETTING CONFERENCE BETWEEN PARTIES**

On or about March 26, 2007, Prudhomme's Lost Cajun Kitchen ("Complainant") filed a complaint against UGI Utilities, Inc. ("Respondent"), at the above-captioned docket number. On or about April 23, 2007, Respondent filed an answer to the complaint.

Based upon a review of the information contained in this material, the parties are hereby directed to discuss this matter to determine whether such discussion can result in a resolution of the complaint and, if so, whether Complainant wants to withdraw the complaint. Respondent shall contact Complainant, on or before May 15, 2007, concerning a mutually convenient time, date and place for Respondent and Complainant to hold a conference. The conference must take place no later than May 29, 2007 unless this is not possible.

**Within ten (10) days following the conference, Respondent shall file a short report with Herbert R. Nurick, Mediator ("Mediator"), setting forth:**

- (a) The time, date and place of the conference;
- (b) Who participated for each party; and
- (c) A statement on the results of the conference.


