INTERIM ORDER  
SETTING CONFERENCE BETWEEN PARTIES

On or about March 21, 2007, Carolyn A. Fonte ("Complainant") filed a complaint against West Penn Power Company ("Respondent"), at the above-captioned docket number. On or about April 18, 2007, Respondent filed an Answer to the complaint.

Based upon a review of the information contained in this material, the parties are hereby directed to discuss this matter to determine whether such discussion can result in a resolution of the complaint and, if so, whether Complainant wants to withdraw the complaint. Respondent shall contact Complainant, on or before May 8, 2007, concerning a mutually convenient time, date and place for Respondent and Complainant to hold a conference. The conference shall take place on or before May 22, 2007, unless this is not possible.

Within ten (10) days following the conference, Respondent shall file a short report with Bruce Bigelow, Mediator ("Mediator"), setting forth:

- (a) The time, date and place of the conference;
- (b) Who participated for each party; and
- (c) A statement on the results of the conference.






