**INTERIM ORDER
SETTING CONFERENCE BETWEEN PARTIES**

On or about October 30, 2006, 3110 Township Line, Inc. ("Complainant") filed a complaint against PECO Energy Company ("Respondent"), at the above-captioned Docket Number. On or about December 11, 2006, Respondent filed an answer to the complaint. It appears that Dominion Retail, Incorporated ("Dominion") might be involved in this matter.

Based upon a review of the information contained in this material, the parties are hereby directed to discuss this matter to determine whether such discussion can result in a resolution of the complaint and, if so, whether Complainant wants to withdraw the complaint. Respondent shall contact Complainant and Dominion on or before January 8, 2007, concerning a mutually convenient time, date and place for Respondent and Complainant to hold a conference, and to ascertain whether Dominion will participate voluntarily. The conference shall take place on or before January 22, 2007, unless this is not possible.

Within ten (10) days following the conference, Respondent shall file a short report with Bruce Bigelow, Mediator ("Mediator"), setting forth:

- (a) The time, date and place of the conference;
- (b) Who participated for each party; and
- (c) A statement on the results of the conference.


If it is not possible to have the conference by the date set for that purpose, Respondent shall file a report with the Mediator, on or before ten (10) days following the conference due date, giving the reason(s) why the due date could not be met.

In either situation, a report must be filed with the Mediator by the applicable due date set forth above.






