INCREASE IN RATES**

(b) B & K Moving & Hauling, Inc. furnishes household goods in use service throughout the Philadelphia area and transported distances of forty (40) miles or less as more thoroughly described in the official tariff. The carrier has filed Tariff Freight Pa. PUC No. 4. The carrier is requesting a 7.0% increase in the hourly charges to cover projected increases in expenses of \$7,233. The proposed rates are to become effective May 31, 2004.

(c) The Bureau recommends that the Tariff Freight Pa. PUC No. 4 as filed by the carrier be permitted to become effective May 31, 2004.

BY THE COMMISSION:

B & K Moving & Hauling, Inc., has filed Tariff Freight Pa. PUC No. 4 on February 26, 2004 and proposes a total increase in revenues of \$6,920 to cover increased operating expenses of \$7,233. The current rates have been in effect since December 17, 2002.

Carrier proposes to increase its hourly 3 men and vehicle normal complement charge by 6.97%. Carrier currently charges \$86.00 per hour and proposes an increase to \$92.00 per hour.

Carrier's total 2003 household good revenue from operations is \$99,284 which is entirely derived from intrastate operations.

Carrier has submitted a tariff and documentation, in compliance with 52 Pa. Code §23.67(c), for carriers of household goods in use, with gross annual intrastate revenues of less than \$200,000.

ANALYSIS

In order to generate this revenue increase, Carrier proposes to increase its 3 men and vehicle normal complement charge of \$86.00 per hour to \$92.00 per hour. We conclude that the data compiled and submitted by the carrier supports this increase.

Staff review of Commission records reveals that Heritage Moving Systems, Inc. to Tariff Freight Pa. PUC No. 12, effective June 30, 2003 is charging \$108.00 per hour. James C. Logan, Inc., Tariff Freight Pa. PUC No. 15, effective August 11, 2003, is charging \$100.00 per hour.


CONCLUSION

We have determined that B & K Moving & Hauling, Inc., has submitted the documentary justification to support the proposed revenue increase of \$6,920, and that the increase is not of an excessive amount based on the operating ratio. The carrier avers that the increase will be sufficient to provide safe, dependable and continuous service to the public: THEREFORE,

IT IS ORDERED:

1. That Tariff Freight Pa. PUC No. 4 be approved to become effective May 31, 2004.
2. That a copy of this order be served upon the carrier.
