INTERIM ORDER  
SETTING CONFERENCE BETWEEN PARTIES

On or about December 12, 2001, Kim L. Jones ("Complainant") filed a complaint against Verizon Pennsylvania Inc. and Metropolitan Edison Company d/b/a GPU Energy, a First Energy Company ("Respondents"), at the above-captioned docket numbers. Respondents filed answers to the complaints.

Based upon a review of the pleadings, the parties are hereby directed to discuss this matter to determine whether such discussion can result in a resolution of the complaint and, if so, whether Complainant want to withdraw the complaints. Respondents shall jointly contact Complainant, on or before February 26, 2002, concerning a time, date and place for Respondents and Complainant to hold a conference. The conference shall take place on or before March 12, 2002, unless this is not possible.

Within ten (10) days following the conference, either or both Respondent(s) shall file a short report with Bruce Bigelow, Mediator ("Mediator"), setting forth:

- (a) The time, date and place of the conference;
- (b) Who participated for each party; and
