Dear Secretary Chiavetta:

I am writing concerning the proposal by Buckeye Partners to reverse the flow on their Laurel pipeline between Altoona and the greater Pittsburgh area. I believe that this change will have impacts that may adversely affect the Commonwealth of Pennsylvania. From increases in fuel prices in western Pennsylvania to damaging the refineries in southeast Pennsylvania, potential job losses, and an increase in truck traffic, this proposal will have great consequences for the community.

The greater Pittsburgh fuel market is supplied by multiple pipelines from Ohio and Chicago based refineries, but the Laurel pipeline is the only one line that feeds Pittsburgh from the east. Reversing Laurel may make it impossible to move fuel to Pittsburgh via pipeline. Currently, the Pittsburgh area fuel retailers are able to buy product from the Midwest or from the southern PA refineries. The pipeline reversal will eliminate this option and make it substantially more difficult for a competitive environment to exist.

Furthermore, transporting gasoline from Altoona to Pittsburg would exacerbate congestion on our already busy roadways. This proposal would add hundreds of trucks per day to Pennsylvania highways, increasing the strain on our infrastructure and causing more environmental and noise pollution. The proposed reversal would also severely restrict the ability of the southeastern Pennsylvania refineries to distribute their refined products to the west. These refineries employ well over 1000 that may be threatened should this reversal move forward.

The Buckeye proposal must be examined. I request that the matter be referred to an administrative law judge for a hearing so that all parties may detail their wide-ranging concerns. It is imperative that a change of this magnitude be given the due diligence it deserves.




