This tariff contains the descriptions, regulations and rates applicable to the competitive local exchange telecommunications services provided to business customers by FiberNet Telecommunications of Pennsylvania, LLC, on a resale and facilities basis, furnished within the Commonwealth of Pennsylvania.

The Company's tariff is in concurrence with all applicable State and Federal Laws (including, but not limited to, 52 Pa. Code, 66 Pa.
