Pursuant to paragraph 26 of the Joint Petition for Approval of Settlement, page 30 of the Initial Decision dated August 21, 2015, and the final Order dated December 3, 2015 in the above-captioned proceeding, the Commonwealth of Pennsylvania, Office of Attorney General, through the Bureau of Consumer Protection and the Acting Consumer Advocate, Tanya J. McCloskey (collectively, Joint Complainants), provide the following report on the distribution of the refund pool.

As indicated in prior Administrator Reports, on November 23, 2016, the Settlement Administrator sent a second distribution of refund checks to all consumers who were eligible for a refund, yet failed to cash the refund checks distributed on May 13, 2016. The second checks replaced previous checks the consumers received and which had expired. The second checks expired on December 23, 2016. The Settlement Administrator, on behalf of the Commonwealth of Pennsylvania, Office of Attorney General, through the Bureau of Consumer Protection and the Acting Consumer Advocate, Tanya J. McCloskey, is in the process of transferring all outstanding property to the Commonwealth Treasurer's Office in accordance with Pennsylvania's Unclaimed/Abandoned Property Law. The Joint Complainants will provide a final Administrator Report once the process of escheating the remaining funds to Treasury and closing out the Account is completed.
