1.

The Petitioner has received a completed version of the proposed settlement agreements and its attendant documents by email dated January 26, 2017.

Counsel for the Petitioner and Counsel for the Plaintiff believe that they have an agreed upon proposed settlement agreement.

The Petitioner met with the Plaintiff late in the first week of February and reviewed the documents prior to the Plaintiff signing them.

At that time, the Plaintiff requested that he be able to review the documents at home prior to signing them and returning them to the Petitioner.

The Plaintiff contacted the Petitioner the morning of February 6, 2017 to request additional time to address specific questions to the Petitioner about the settlement documents.


