Respondent, KLLM, Inc., has paid the amount sought by the Pennsylvania Public Utility Commission's Bureau of Investigation and Enforcement (I&E) in order to resolve the above-docketed complaint. On December 7, 2016, the Commission received payment in the amount of \$500 which was the civil penalty sought by I&E in the above-referenced complaint alleging violations of the Commission's regulations. In his letter dated December 5, 2016, the Company's CFO also indicated that a Form E proof of liability insurance had been filed. Finally, the Motor Carrier Compliance Group of the Commission's Bureau of Technical Utility Services advised I&E that an acceptable Form H for KLLM, Inc. was also received by the Commission on January 23, 2017.
