Financial Fitness - Resumes

Jere Thompson, Jr. Chief Executive Officer (CEO) & Co-Founder Ambit Northeast, LLC

Mr. Thompson co-founded Ambit Energy Holdings in 2006. In the past seven years, Ambit has expanded into thirteen states and the District of Columbia and now serves over one million retail electricity and natural gas customers. In 2014, Ambit recorded revenues of \$1.5 million, up 24% over 2013 revenues. Ambit employed 621 people at year-end 2014. Mr. Thompson has had the primary responsibility for crafting and implementing Ambit's strategy, recruiting and managing its executive team, accessing and securing growth and working capital, risk management, internal resource allocation, managing the senior relationships with Ambit's primary wholesale power and gas supplier, and monitoring and evaluating hedging positions in Ambit's major power market.

From 1992 through 2000, Mr. Thompson was the Founder and Chief Executive Officer of CapRock Fiber Network, and its successor, CapRock Communications Corp. During Mr. Thompson's tenure, CapRock grew from a fiber optic network start-up to a publicly traded corporation generating \$300 million in revenue with over 1,300 employees. CapRock provided dark fiber, bandwidth, data, and long distance and local telephone services in deregulated telecom markets. As CEO, Mr. Thompson held primary responsibility for setting CapRock's strategy, recruiting and overseeing its executive management team, securing start-up and growth capital, acquisitions, and profit and loss responsibilities.

Previously, Mr. Thompson was a Vice President at The Thompson Company, a family investment firm, at Trammel Crow Community Development, a commercial real estate development firm, and was an analyst at Goldman Sachs & Co. in New York in the investment banking division.

Mr. Thompson holds a Bachelor's degree in Economics from Stanford University and a MBA from The University of Texas. Mr. Thompson has more than 15 years of deregulated utilities sales experience, enterprise financial and administration responsibilities, profit and loss responsibilities for both publicly and privately held corporations and partnerships.

Chris Chambless Chief Marketing Officer

Chris Chambless is the Co-Founder and Chief Marketing Officer of Ambit Energy. He leads the company's efforts to establish a nationally recognized retail brand in the energy industry utilizing the power of person-to-person marketing.

As an early member of the management team at Excel Communications, he was responsible for all aspects of the company's marketing and communications organization. Most recently, as the Vice President of Marketing at VarTec Telecom, he was responsible for all aspects of the company's marketing strategy, including brand development, channel integration strategy, sales management and new product development.
