improper Finding of Facts

My "flawed reasoning",
as you put it, was
simply asking someone
to show how my situation
fits in to the category of
"Foreign Load", which is
explained as the Landlord
attaching an electric load
to a separate building for
his use.

In my situation, I
explained that a portion
of my garage/shed was
set up for Tenant use

only. (For their automobile
and lawn equipment)

The only lead to
the tenants house was
a 110V night light
over their garage door.

I also advised the
Tenant had a key to
the garage door.

I only repeated the fact
that I deducted one-half
of the total cost of the
Building on my Fed Tax
return to further prove

my intention that that part
of the garage was for tenant
only (Fed Tax law - must be related
or part of an income producing
business.)

Please note that my
part of the garage for
tractors & tools had its
own power source from
306 Halden Rd.

Swear your employees,
Joseph Belmont agreed with
me, though disappointed &
hadn't challenge the

legality of the "Foreign
Load" law in my case
I advised her that
had I created a
"foreign load", as explained
by PUC, I would deserve
being faulted.

understand how his actions caused a foreign load. Regardless of this, the ALJ already determined that a foreign load existed, and that PPL did not violate the Code, a Commission Order or regulation, or a Commission-approved tariff. See generally Findings of Fact 1-22 and Conclusion of Law 14. Mr. Carmody's Exceptions are meritless, insofar as he has failed to include any arguments in his Exceptions which demonstrate that the ALJ erred in this regard.

In sum, Mr. Carmody's Exceptions must be dismissed because they were untimely filed, and in fact, filed after the Commission ordered that this matter be marked closed. Second, Mr. Carmody's Exceptions must be dismissed because they fail to conform to the requirements of the Code. Last, Mr. Carmody's Exceptions must be dismissed because they fail to allege that Judge Cheskis made an improper finding of fact, and/or improperly applied the law to the facts of this case, and/or reached an inappropriate conclusion of law. Rather, Mr. Carmody has simply reiterated information which he already presented to the ALJ in support of his flawed reasoning that a foreign load was not present on his property and/or that even if a foreign load was present, he should not be responsible for the resultant balance from his tenant's account. However, the ALJ already heard this evidence and rendered an appropriate decision. In light of this, Mr. Carmody's Exceptions are without merit.

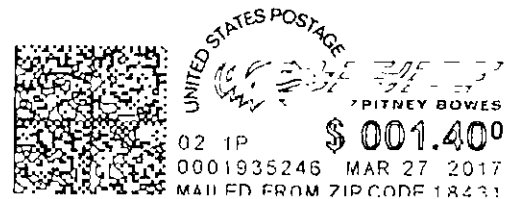
