**MOTION FOR CONTINUANCE OF HEARING**


Pursuant to 52 Pa. Code § 1.15(b), the Philadelphia Gas Works (PGW) hereby submits this request for a continuance of the hearing in this matter, which is scheduled for Tuesday, April 11, 2017. In support of its motion, PGW states as follows:

1. By Notice dated March 9, 2017, the Commission scheduled a Telephonic Hearing in this matter for Tuesday, April 11, 2017, at 10:00 a.m., before Special Agent Rebecca Waldemar.
2. PGW appreciates that it is the policy of the Commission to encourage settlements and in the spirit of 52 Pa. Code § 5.231(a), the parties are actively pursuing a resolution; however, both parties must wait for information from the Social Security Administration and PGW does not foresee any resolution to this case being reached by the scheduled hearing date.
3. PGW has discussed a continuance in this matter with the Complainant. Ms. Doctor has no objection to the request for the continuance as she agrees with PGW that any meaningful attempt at a resolution will take place after both parties have the necessary information.

**WHEREFORE**, PGW requests that the hearing scheduled for Tuesday, April 11, 2017, in the above captioned matter be continued so that the parties may attempt to settle the matter without a hearing.




