Dear Secretary Chiavetta:

Pursuant to Pennsylvania Public Utility Commission's ("Commission") Final Order entered on July 24, 2014 in Docket No. M-2013-2393141, Ambit Northeast, LLC ("Ambit") hereby respectfully requests that its financial security requirements be reduced from 10% to 5% of its most recent twelve months of revenue. In support of this Letter Petition, Ambit has enclosed the following documentation for filing with the Commission:

- 1.) Gross revenues for the sale of electricity to retail customers in Pennsylvania for the most recent 12 months, attached hereto as Attachment A (CONFIDENTIAL);

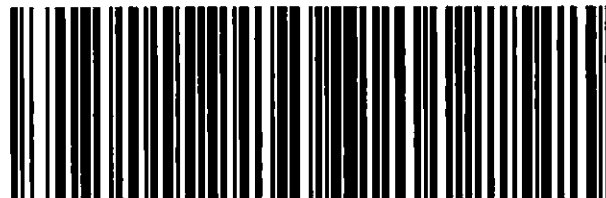
