
On behalf of Brookfield Development Corp. (Petitioner), I kindly request that the hearing scheduled in this matter for April 6, 2017 be cancelled and rescheduled for an available hearing date in July 2017.

Brookfield Development Corp. ("**Brookfield**") continues to diligently work on reaching an amicable resolution with respect to the provision of public water service to its proposed residential development. Brookfield has identified an adjacent municipal authority that is willing to provide public water service in lieu of the City of Lancaster, however, Brookfield must acquire property and/or easements to install required water infrastructure facilities to be able to provide the domestic water service. In addition, the City of Lancaster and the adjacent municipal authority have an existing intermunicipal agreement that will need to be modified once the final details have been determined.

As such, given the ongoing nature of these discussions, Brookfield requests, and the City of Lancaster agrees, that the hearing in this matter be cancelled and rescheduled.

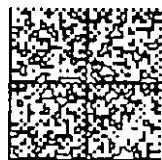
