This is a formal petition to request a reconsideration of the Five hundred dollars (\$500.00) fine that was imposed to TAXI EXPRESS LLC due to the following:

1. In July of 2016 TAXI EXPRESS LLC received a NOTICE SUSPENSION OF PUC OPERATING AUTHORITY.
2. TAXI EXPRESS LLC contacted its insurance carrier to make sure that everything with our insurance was in order, and agent assured us that everything was in order.
3. A letter (ref A 2014-2438369) dated of July, 19<sup>th</sup>, 2016, NOTICE OF LIFTED SUSPENSION OF PUC OPERATING AUTHORITY was received by TAXI EXPRESS LLC.

5. TAXI EXPRESS LLC did not respond to the letter (Ref C – 2016 – 2556550), dated July, 20<sup>th</sup> 2016, because we assumed that the letter (ref A 2014-2438369) dated of July, 19<sup>th</sup>, 2016, NOTICE OF LIFTED SUSPENSION OF PUC OPERATING AUTHORITY had already taken care of the issue.
6. TAXI EXPRESS LLC received a letter (Ref C-2016-2556550), In Re: Pennsylvania Public Utility Commission v. Taxi Express LLC, dated March 8, 2017.

TAXI EXPRESS LLC contacted PUC through Mrs Tatiana Roth to whom we explained all the above and we were advised to write this petition and always contact the Commission regardless of what our insurance agent tells us.
