Additional Information Regarding this case:

According to Exhibit 1, the tenant transferred a balance of \$1,111.09 when they established service at 633 Andrews Avenue, 1st Floor, Collingdale, PA 19023 on 7/15/2015. They made a payment agreement on 10/23/2015 of 23.24 per month. They only paid 7 months on the payment agreement (11/6/15, 12/9/15, 1/12/16, 3/11/16, 4/11/16, 5/10/16 and 7/11/16) which is \$162.68. WE SHOULD NOT BE RESPONSIBLE FOR THIS CARRYOVER BALANCE ALONG WITH NON PAYMENT OF THEIR ELECTRIC BILL.

We have corrected the foreign wiring and since our monthly bill has averaged \$15 per month.


Again, I agree to pay my share of the balance but not the entire balance.

I cannot afford a lawyer and this is way over my legal ability. I am a retired contractor with a fixed income. The tenants left the property so devastated that I have not been able to rent it out since they left. I cannot afford to make the thousands of dollars of repairs to the property or hire a lawyer to assist me in this process.

I request a hearing so I can state my case in front of a judge.
