Pursuant to the Commission's March 18, 2010 Secretarial Letter in the above-referenced docket, enclosed for filing is documentation proving AEP Energy, Inc. (f/k/a BlueStar Energy Services, Inc. ("BlueStar")) is a signatory to PJM's Reliability Assurance Agreement ("RAA").

This is the same documentation that was filed last year as it is still in effect. 
