I am responding to the complaint that has been filed against Rolling Hills Services Inc. (C-2017-2602072)
On 04/07/2017 the business had decided to shut down its operations and sell their truck and trailer. On 04/16/2017 Rolling Hills Services Inc obtained new coverage through United Financial Casualty Company so that the vehicle would be covered while the potential buyer would be test driving the vehicle.
On 05/03/2017 Rolling Hills Services Inc sold the Truck and Trailer and we ordered the policy cancelled.
I have enclosed copies of the new policy which they obtained along with copies of the pink slips showing that the vehicles have been sold.

Knowing that they were no longer going to be operating the vehicle in question the renewal filings were not made with the PUC.

They did however obtain new coverage so they were never without renewing their coverage on 04/16/2017.

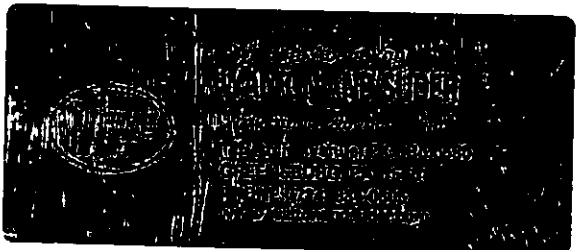
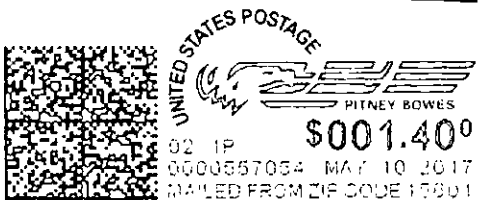
