MOTION FOR CONTINUANCE OF HEARING


Pursuant to 52 Pa. Code § 1.15(b), the Philadelphia Gas Works (PGW) hereby submits this request for a continuance of the hearing in this matter, which is scheduled for Thursday, May 26, 2017. In support of its motion, PGW states as follows:

1. By Notice dated March 31, 2017, the Commission scheduled a Telephonic Hearing in this matter for Thursday, May 26, 2017, at 10:00 a.m. before Administrative Law Judge David A. Salapa.
2. PGW and the Complainant are actively pursuing a resolution, but will not be able to come to an agreement by the scheduled hearing date.
3. PGW has discussed a continuance in this matter with the Complainant. Mr. Jakubowski has no objection to the request for the continuance as he is still in the process of obtaining the information necessary for the parties to resolve the case; he believes that a short continuance should suffice as he will be able to obtain the necessary information very soon.

WHEREFORE, PGW requests that the hearing scheduled for Thursday, May 26, 2017, in the above captioned matter be continued so that the parties may attempt to settle the matter without a hearing.




