Dear Secretary,

In December, 2016 Vista Energy Marketing, L.P. (“Vista Energy”) was granted an NGS license in Docket A-2016-2569541. Information about Vista Energy’s ownership structure was provided to the PUC during the review of that application.

Per an agreement entered into on May 9, 2017, Vista Energy obtained an additional limited partner (Whale Family Investments, LP), bringing the total number of limited partners to three. The new agreement divides the former passive ownership interest of Whale Capital, L.P. into two pieces, Whale Capital, L.P. and Whale Family Investments, LP, but does not otherwise alter the corporate control of the Whale side of Vista Energy Management. There is no change to the general partner or to any other aspect of Vista Energy’s upstream ownership or control. An updated response to Item 2b on the Vista Energy NGS application has been attached.




