Constellation Energy Gas Choice, LLC ("CEGC") will assign Pennsylvania retail gas customers to their affiliate, Constellation NewEnergy-Gas Division, LLC ("CNEG") in June.

We have discussed with the Office of Competitive Markets Oversight ("OCMO") that the nature of this intracompany transaction is the equivalent of a minor name change and a license change. As such, the sending the usual full-notice as described in revised PA Code is not desirable because it may only confuse the customers. We have been advised that an abbreviated notice providing the new name and license number is appropriate and we will be sending this to our affected customers either as a separate mailing, or for those customers whose contracts renew in July, as part of their initial renewal notice. The text of the abbreviated notice is enclosed and will be sent on Constellation letterhead.

OCMO directed us to the NGDCs and have them suppress the enrollment confirmation letters. We understand that this is generally standard practice in any assignment process.
