On September 12, 2014, Stream Energy Pennsylvania, LLC ("Stream Energy") filed a petition to reduce its bond with the Pennsylvania Public Utility Commission from 10% to 5% of Stream Energy's most recent twelve months of revenue pursuant to the Commission's Final Order entered July 24, 2014 at Docket No. M-2013-2392141. Stream Energy's security reduction petition was granted by Secretarial Letter dated September 4, 2015 and was renewed in 2016.
